Dear Friends and Supporters,

It seems like the past year has gone by in the blink of an eye. We are pleased to report that, during that "blink," the Knoxville Area Urban League has accomplished much in the areas of Education and Youth, Job Readiness and Employment Assistance, Housing Counseling and Home Ownership, and Small Business Development.

Thanks to the hard work of a committed staff, a dedicated Board of Directors and committed volunteers, the Urban League served more than 8,000 people in 2010, making a real impact in our community. To give a snapshot of some of our successes, we:

- Inducted 125 scholars into our National Achievers Honor Society, helping increase the probability of college enrollment for these gifted scholars, many of whom are at-risk and the first in their families to go on to post-secondary education.
- Provided new shoes and school supplies to 1,000 area children who most needed our help.
- Provided employment counseling to more than 900 people and skills training to more than 225, and placed 85 in employment, many of whom were hard to place, such as the previously adjudicated.
- Provided housing counseling to 449 people, foreclosure prevention and mortgage default assistance to 149 people, and helped 48 people purchase their first homes, adding nearly \$6.5 million to the tax rolls.
- Made small business loans totaling \$650,000, creating 20 new jobs.

The work that we do wouldn't be possible without the financial investment of government funding, foundations, corporate and individual supporters, and the United Way of Greater Knoxville.

As we enter a new year of service, there will be new challenges and opportunities. We are thankful for those who join us as we endeavor to empower communities and change lives.

In the words of Marc Morial, president and CEO of the National Urban League, "We've made great strides, opened many doors and created opportunities for many. But more work remains to be done, and we are guided by the spirit of determination and dedication that moved our founders."





In 2008, we were one of 24 nonprofit agencies selected by the Tennessee Housing **Development Agency to** participate in the federally funded National Foreclosure **Mitigation Counseling** program which was enacted by Congress to provide counseling to homeowners facing foreclosure.

Through our Micro-Lending Program, we work to create and expand business opportunities for socially and economically disadvantaged people in Knoxville and the surrounding area.
